Waubun Ogema White Earth Community Schools assure participation and access to all program activities through the use of social media, quarterly newsletters sent to parents and publishing in the local tribal newspaper. We also conduct quarterly parent committee meetings and monthly radio broadcasts of programs and services offered to all students. We make accommodations for students who are on IEP's to fit students special needs. PreK-12 parents, teachers and students are asked to complete yearly surveys to indicate their personal needs and preferences for day and after-school programs, services and activities. A public hearing is held each October and in the spring in order to educate the general public of services offered at Waubun Ogema White Earth schools. Facilitators for cultural activities are selected by Indian Education Staff, community leaders, and the tribal council through Tribal Consultation. Teachers are given a copy of the proposed education plan and budget asking for input to make sure all students will have access to activities and be successful. We work hard to address individual and systemic barriers to participation. Parents, students, teachers and community can access program information and problem solve through multiple access points. The Indian Education Director, the Home Liaison, the counseling office, an instructor, the problem solving team, Cultural and Language teacher, any administrator and office support staff. All program information is in our back to school information and handbooks inviting all students to participate. All program plans are posted at the Indian Education link on our school website. Assessment data from the previous year is used to indicate where services should be offered in order to help all students achieve school and academic success. These procedures are consistent with School Board Policy 612.2 - Policies and Procedures Ensuring Tribal and Parental Involvement in Education.

2.7 Comments

We offer language and culture to all students in grades Pre-K - 12, as well as services to increase attendance, dropout prevention, closing the achievement gap and counseling/college guidance. We have a Cultural Student Success Coordinator who will be monitoring attendance and provide interventions for students and guide students and parents to the appropriate resources and interventions to increase achievement and school success as well as increasing our graduation rate. Our Ojibwe Language and Culture Teachers will teach language and culture Pre-K - 12 for half of the day and will spend the other half doing interventions and liaison services. We have 1FTE located at each of our sites, Waubun and Ogema. With the collaboration of programs, it has helped build and broaden our Indian Education offerings of programs and activities.
