Chad Luther, principal of the South Lewis Senior High School, Turin, is pleased to announce the names of the students receiving the highest honors for the Class of 2021. Madison O. Munn has achieved the highest honor of Valedictorian; Jayden M. Denslow has earned the distinction of Salutatorian; and Shane C. Sweredoski has been named this year's Technical Honor Student.

With an overall average of 99.28, Madison O. Munn is the Class of 2021 Valedictorian. Madison is the daughter of Timothy and Lisa Munn of Lyons Falls. Madison has been very active during her high school career and has maintained a leadership role among her peers. She has excelled in academics, participated in many school-related activities, and stays busy with responsibilities away from school as well.

In addition to focusing on academics and maintaining high honor grades, Madison works to contribute to her school community in other ways. She has been a member of "Students Against a Vanishing Environment" ("S.A.V.E."), a mentor in the "Falcon Friends" program, and a peer leader in the "Sources of Strength" project. Over the years, Madison has devoted time to the South Lewis Girls' Athletic Association and to the Whiz Quiz Team. Madison was also elected by her classmates to serve as Class of 2021 Vice President during her sophomore and junior years and as Senior Class President this year. In the past, Jayden has participated in "Students Against a Vanishing Environment" ("S.A.V.E."), a school-wide recycling initiative, and has also been a Falcon athlete. As a player on the JV Volleyball Team, Jayden was appointed Team

Captain in her sophomore year. Currently, Jayden is a member of The Morgan Lewis Chapter of National Honor Society and was named a Class of 2021 South Lewis Lions Club Scholar. With an overall average of 90.81, Shane C. Sweredoski is this year's Technical Honor Student. Shane is the son of Timothy and Rebecca Sweredoski of Constableville. As a high school student, Shane has excelled in academics, both at South Lewis and in the BOCES Engineering & Design program, has enjoyed success as a varsity athlete, and has remained active at school and during his time away from school.

Currently, Shane is a BOCES student enrolled in Jefferson Community College's EDGE program that is located at the Lewis County JCC Education Center in Lowville. In that two-year engineering and design program, Shane has participated in the student leadership organization "SkillsUSA," has achieved honor roll grades, and was a recipient of the "Outstanding Performance" award in June, 2020. As a student at South Lewis, Shane maintained honor roll grades throughout his high school career, and, earlier this year in recognition of his dedication to his studies, Shane was identified as a Class of 2021 South Lewis Lions Club Scholar. As a junior, Shane was selected to represent South Lewis in the prestigious American Legion Boys State program. In addition, Shane has also been acknowledged for his outstanding character and has been selected, on more than one occasion, as the "South Lewis High School Student of the Month." Dear Parents, Residents, Community Members and Faculty/Staff:

On behalf of the Board of Education we present a Capital Improvement Project that will impact the South Lewis Central School District and our community for generations to come. We know that education is the most important investment source of great pride as well as a significant investment by our local community.

On October 23rd the District is asking the voters to act on a \$38,889,800 Capital Improvement Project that has been developed through input from parents, community members, and faculty/staff. This vote is a **revised and scaled-down version of the Capital Project that was narrowly defeated last December**. This revised project has a significantly reduced tax impact to the community. While the project includes:

- Renovations to the facilities located at the Middle-High School campus
- Construction of a new elementary addition/wing onto the Middle-High School addition
- Acquisition of land adjacent to the Middle-High School for athletic field additions
- School is being donated to the school district if the project is approved by the voters.

Future closure of the Glenfield and Port Leyden Elementary Schools

More detailed information including changes from the original project, highlights of the work to be done, and costs can be found in this brochure. A Public Hearing is being held on Monday, October 15th at 6:30 PM at Middle-High School, 800 PM in the Middle-High School Music Suite. In order to vote you must be 18 years-of-age and have your primary/permanent residence in the school district for at least the past 30 days.

Three (3) vacancies exist on the Board of Cooperative Educational Services to be filled at the annual election to be held in component school districts on April 21, 2021. Three (3) candidates have been nominated to fill these three vacancies. The members of the Board of Education of each component school district vote as a block by adopting a resolution and casting one (1) vote for each of the three vacancies to be filled. No more than one vote may be cast for any candidate. Each vacancy is for a three (3) year term of office (July 1, 2021-June 30, 2024). The three (3) candidates receiving the highest number of votes will be elected to the three (3) year terms on the BOCES Board. No more than one person residing in a particular component school district may be elected to serve on the Board of Cooperative Educational Services at one time, except as provided in Education Law §1950 (2-a). MEMORANDUM OF UNDERSTANDING

ELECTION SERVICES AGREEMENT BETWEEN LEWIS COUNTY BOARD OF ELECTIONS AND SOUTH LEWIS CENTRAL SCHOOL DISTRICT BOARD OF EDUCATION CONCERNING SOUTH LEWIS CENTRAL SCHOOL DISTRICT VOTE AND ELECTION TO BE HELD ON MAY 18, 2021

THIS MEMORANDUM OF AGREEMENT, is entered into between the Lewis County Board of Elections, with offices at 7550 South State Street, Lowville, NY 13367 (hereinafter referred to as the "Board of Elections") and the South Lewis Central School District Board of Education, with offices at 4264 East Road, Turin, NY 13473 (hereinafter referred to as the "School Board").

WHEREAS, the School Board is holding an election on **May 18, 2021**, and is seeking the assistance of the Board of Elections, in providing election services consisting of the provision and usage of voting machines, all equipment and supplies necessary to conduct voting operations; as well as training and assistance concerning voting operations;

WHEREAS, pursuant to Section 3-224 of the New York State Election Law, the Board of Elections may permit school districts within the county to use its voting machines and other equipment, for the conduct of elections, upon such terms and conditions as shall be fixed by the Board of Elections and agreed to by both the Board and the School District; and

WHEREAS, pursuant to Education Law §2035(1), the School Board is authorized, if the County Board of Elections shall consent thereto, to use voting machines belonging to the County Board of Elections.

NOW THEREFORE, the parties named above hereby enter into this Agreement applicable to the **South Lewis Central School District Election being held May 18, 2021, and any subsequent revote(s) related thereto** (hereinafter referred to as the "Election"):

I. BOARD OF ELECTIONS

1. The Board of Elections shall:

- a. Provide and deliver optical scan voting machines and privacy booths to the School Board in a number deemed adequate upon mutual agreement between the parties.
- b. Provide four trained Board of Elections poll workers for election day.
- c. Subject to the School Board's review and approval, define the ballot in terms of format and language. The ballot will be provided in a PDF form for the School Board's review and approval.
- d. Program all voting machines after receiving PDF approval for the definition of the ballot.

- e. Provide the services of Board of Election staff that shall create ballot definition and corresponding PDFs, conduct pre-election testing of the voting machines, deliver the voting machines and, any other equipment, supplies, and provide technical assistance as needed. The Board of Elections will not be conducting a post-election audit unless authorized or directed to do so in accordance with the provisions of the Education Law.
- f. Said Board of Elections staff shall respond immediately to South Lewis Central School poll site should a scanner situation arise wherein the Election Inspectors are unable to resolve.
- g. Forward said approved ballot definition in PDF format to the printer as identified by the school district for the purpose of test ballot printing and official ballot printing. The School Board shall be responsible for all printing costs.

II. SCHOOL BOARD

- 1. The School Board and/or its representative shall:
 - a. Provide the Board of Elections with the ballot layout and content in a timely manner.
 - b. Work with the Board of Elections to determine the number of machines and ballots needed for the election in a timely manner.
 - c. Provide the Board of Elections of its review and approval of the ballot definition PDF, via signed copies of said PDF in a timely manner.
 - d. Pay \$90.00/flat rate for the transportation of voting machines to and from school district poll sites, to be paid in full upon receipt of invoice from Board of Elections.
 - e. Pay \$125.00/flat rate for each inspector provided by the Board of Elections
 - f. The School Board shall be responsible for all printing costs, to be paid in full upon receipt of invoice from the Board of Elections. (Board of elections will only order the number of ballots requested by the District Clerk, Board of Elections is **NOT** responsible for any ballot shortages)
 - g. Clerk of the School Board shall be responsible for proper notice of said election.
 - h. Clerk of the School Board shall remain the responsible person of absentee processing; The Board of Elections shall supply a list of permanently disabled voters entitled to receive an absentee ballot within your district.
 - i. Shall make available a three prong grounded outlet, table and four chairs for Board of Election use on election day.

This Memorandum shall be subject to the approval of the South Lewis Central School District Board of Education as well as the Lewis County Board of Elections.

Re: Participation in RIC Bids with Non-General Fund Dollars

The Mohawk Regional Information Center helps school districts purchase hardware and software to complement school technology plans, regardless of the source of funding or the source of state aid. Additionally, the MORIC provides installation and support services to school districts to ensure consistency with existing technology, follow-through on the function of the equipment, and on-going support and accountability.

When these purchases are made with building aid funds, hardware aid funds, and/or grant funds instead of general funds, they do not qualify for BOCES aid and the district retains ownership of the items purchased. "BOCES" should not be listed as a vendor on Final Cost Reports for building projects.

If you wish to purchase from the MORIC regional bids for technology and software using non-general fund dollars, you may do so by having the Board of Education approve the attached Cooperative Bidding Resolution. Next, your assigned Mohawk Regional Information Center Technology Planning Specialist will assist you in the development of a proposal, the initiation of the purchase, and the coordination of the installation and subsequent support. In order to ensure that such purchases that are processed by MORIC do not generate BOCES aid you must identify those items to your Planning Specialist and your local BOCES.

Building aidable or grant funded equipment installed by the Mohawk Regional Information Center will have a "RIC Installed" tag on the equipment. The equipment is owned and insured by the district and not the Mohawk Regional Information Center because the district used grant and/or building project monies. However, the equipment is connected to district networks and other equipment made available through BOCES aidable CoSers.
