BOARD OF EDUCATION MEETING

April 11, 2016

The Winterset Community School District Board of Education met in regular session, Monday, April 11, 2016, at 5:00 p.m. in the boardroom. The following members were present: Karen Brookhart, Kelly Cain, James Baur, and Brenda Clifton. Also present were Superintendent Meade, Board Secretary Leners, staff, students and a member of the press. President Nicholl was absent.

Superintendent Meade shared the public/employee survey as suggested by Dennis Cheesebrow who led the District through the strategic planning process. Also shared was a draft plan of upcoming Board Agendas items that focus on and support the plan.

Motion by Clifton, second by Baur to approve the second and final reading of policy revisions to the 100 series, "School District", the 200 series, "Legal Status of the Board of Directors", the 300 series, "Administration", and the 400 series, "Employees". Motion carried with all Directors present voting in favor.

Public Hearing was then held regarding the Children's Internet Protection Act (CIPA). The Act was read and discussed. The Winterset Community School District addresses student internet safety in Board Policy, specifically policies: 605.6, 605.6R, 605.6E1, 606.6E2, 605.6E3, 605.6E4. There were no public comments or concerns voiced during the hearing.

Motion by Baur, second by Cain to adopt and certify the FY17 District budget as published and discussed at the public hearing held March 28, 2016. The combined total tax levy will be \$17.49 which is the same as the prior year and includes a pre-levy to call General Obligation (GO) bonds saving the District future interest expense. Motion carried with all Directors present voting in favor.
