

PARK COUNTY SCHOOL DISTRICT #6
Special Board Meeting
April 6, 2021

The Board of Education of Park County School District #6 met April 6, 2021 at 5:30 p.m. in the Westside Annex Board Room. Chairman Nelson called the meeting to order and led the Pledge of Allegiance. Board members present: Stefanie Bell, Jessica Case, Tom Keegan, Brandi Nelson, Cathy Roes, Karen Schipfmann and Sheri Schutzman. Administrators present: Superintendent Monteith and Assistant Superintendent, Tim Foley.

Chair Nelson called for approval of the amended agenda.

On motion by Stefanie Bell, seconded by Cathy Roes and carried, the amended agenda was approved.

Mr. Foley shared with trustees that the public comment period on math textbooks for grades 6-12 closes on Friday, April 9 and no comments had yet been received. If none are received, he will forward a request to authorize the purchase of these textbooks at the April 20th meeting utilizing this year's budgeted monies.

Chair Nelson offered discussion on the sale of the old transportation facility by stating bids were due March 30, but none had been received. She shared that she had received information that one party still had interest, but the board would need to extend the deadline. Trustee Keegan asked if any other interest had been shown. Trustee Roes stated she had received an inquiry. After much discussion about extending the bid date, Trustee Roes suggested the bid date be extended to April 16 and to extend the closing date by the same number of days pushing it to May 27th. This would allow for any bids to be acted upon at the April 20th regular board meeting.

Chair Nelson called for action on consent agenda items with a roll call vote.
