# 0478. Election Report

Bobbie Janis from the Fall River County Auditor's Office, was in attendance to report results of the June 7, 2022 State Primary/OLCSD School Board Election. The Board will canvass results following review.

#### 0479. Construction Report

Toby Morris, Construction Financial Consultant, presented several pay apps and invoices for work completed on current construction projects, as well as a change order for the Board's consideration.
