## II. CONTRACTORS REQUIREMENTS

Contractor must be certified to install the Heat Exchanger proposal

Contractor responsible for all licenses/ permits, etc. required by the Oglala Lakota Sloux Tribe

The successful bidder must furnish performance and payment bonds with the appropriate "powers of attorney" in the amount of one hundred percent (100%) of the contract total maximum price from a corporate surety authorized (licensed) by the State of South Dakota

#### V. SCOPE OF WORK

Work shall include all materials, labor, equipment, supervision, accessories and incidentals for the installation of a new Heat Exchanger/Condensing Unit & Evaporator Coll Replacement.

#### **HVAC:**

Remove and properly dispose of existing gym HVAC unit heat exchanger assembly that currently condemned due to being cracked. Provide and install one (1) custom retro fit heat exchanger. Reconfigure gas piping/train as required for retrofit. Reconfigure controls as required. Startup and check out of system. Standard one (1) year warranty on parts and labor

# Replace Condensing Unit and Evaporator Coil

Remove and properly dispose of existing 20-ton condensing unit & coil. Pump down and reclaim refrigerant per latest EPA requirements. Remove existing refrigerant piping. Disconnect controls & power. Provide and install one (1) Trane 20-ton condensing unit w/matched ARI coil. Properly sized, insulated refrigerant piping as required. Install new coil in air handler. Condensate piping as required. Refrigerant as required for new install. Factory authorized startup and check out of system o Standard one (1) year warranty on parts and labor.

#### VI. INSTALLATION

Installation of the Heat Exchanger shall follow the minimum guidelines of manufacturer.

# XI. CLEAN-UP AND PRECAUTIONS

All rubbish accumulated from the job shall be removed from the County's premises by the Contractor at his expense. No trash, or other debris is to be placed in County dumpsters or other trash facilities belonging to County.

The set up area is to be protected from damage to surface of grounds. Extra precaution should be taken as not to damage surrounding building walls, landscaping, parking lots, and side walks.

### XII. WARRANTY

Contractor shall warrant the installation of the heat exchanger system to be free from defects in materials and workmanship for a period of one year.
