0509. Approval of Agenda

0511. Approval of Minutes

Motion by Conroy, seconded by Blue Bird to approve minutes of August 25, 2022 Regular School Board Meeting "B". Motion carried unanimously.

0512. Receipt of Bids

Motion by Conroy, seconded by Blue Bird to accept the bid submitted for the following services from Temperature Technology, Rapid City, South Dakota, as listed:

- a) Rockyford School: Replace Pneumatic Controls on 27 Air Induction VAV's with new DDC Controls, in the amount of \$90,000.00 for Rockyford School, as per submitted bid.
- b) Batesland School: Provide and Install new Custom Fit Heat Exchanger in Gym Unit in the amount of \$40,950.00, as per submitted bid;
- c) Batesland School: Replace Condensing Unit & Evaporator Coil Replacement (air conditioning) in the amount of \$44,100.00, as per submitted bid; for a total amount of \$85,050.00 for Batesland School.

0513. Authorize to Advertise

Motion by Conroy, seconded by Blue Bird to authorize to advertise for bids for Three (3)14-passenger school buses and One (1) 77-passenger school bus. Motion carried unanimously. (Attachment C)

0514. Temperature Technology

Motion by Blue Bird, seconded by Conroy to accept the Maintenance Proposal submitted by Temperature Technology of Rapid City, South Dakota, which will provide for the preventive maintenance of school district heating and cooling systems in all OLCSD schools district-wide. Contract will include all service call labor, mileage, filters and installation twice annually. This Agreement will be in effect January 1, 2023 for a one year period, renewing automatically for three years unless canceled by either party. Motion carried unanimously. (Attachment D)

0515. Back to School Plan Update

Superintendent Kaltenbach presented proposed updates to the Back to School Plan for 2022-23. Motion by Conroy, seconded by Eagle Bull to approve the updates. Motion carried unanimously. (Attachment E)
