0522. Approval of Agenda

0524. Approval of Minutes

Motion by Eagle Bull, seconded by Blue Bird to approve minutes of September 15, 2022 Regular School Board Meeting "A" (Board members Conroy and Two Crow not present). Motion carried unanimously.

0525. Reports

Lakota Tech High School Principal, Chanda Spotted Eagle, provided a verbal report to
the School Board in regard to exciting and unique opportunities the CTE pathways are
providing for students. This would enable them to move directly into the workforce,
having the knowledge and experience in career skills, following graduation.
She also provided information in regard to the teaching staff vacancies and avenues high
school administration is taking to alleviate the shortage. Elementary School Principals
also provided updates in regard to student enrollment.

0527. Construction Updates/Pay Apps

0529. Policies

Superintendent Kaltenbach presented Policy number 7.12: Staff Conduct Policy for the School Board's review. This policy will be presented for the second reading and approval at the Oct. 13, 2022 School Board Meeting "A".

0530. Financial Report & Expenditures

Business Manager Sophia Conroy presented the financial report and expenditures. Motion by Eagle Bull, seconded by Two Crow to approve the financial report and expenditures, as submitted by the business office. Motion carried unanimously. (Attach C)

0531. Vehicle Mileage Rate Adjustment

Motion by Two Crow, seconded by Blue Bird to approve increasing the mileage reimbursement rate, in accordance with the increase in the state of South Dakota's mileage reimbursement rate. Rates will increase to \$0.51 per mile for the high mileage rate (wherein no school vehicle is available, therefore, employee drives their personal vehicle). In addition, establishing the low mileage rate at \$0.28 per mile (wherein a school vehicle is available, however, employee chooses to drive their personal vehicle). Motion carried unanimously.

0532. <u>Tele-Medicine Behavior & Nursing Plan</u>

Health and Wellness Director, Laticia DeCory, presented a one-year contract with Avera for Tele-Medicine Services for students related to school health.

Motion by Conroy, seconded by Two Crow to authorize administration to enter into an agreement with Avel e-Care Medical Group, which would provide mental and physical health counseling services through the tele-medicine program (based upon and to include Batesland School, pending insurance approval). Motion carried unanimously. (Attachment D)

0533. Appoint School Board Delegate

Motion by Conroy, seconded by Two Crow to appoint Board Member Bryan Brewer, School Board President, to attend and represent the Oglala Lakota County School Board, at the Associated School Boards of South Dakota Delegate Assembly in Pierre on November 18, 2022. Motion carried unanimously. (Attachment E)

0534. Rockyford School Survey

Motion by Eagle Bull, seconded by Two Crow to grant permission to the Tri-Ethnic Center for Prevention Research, sponsored by Colorado State University, to conduct a completely anonymous on-line survey with 6th through 8th grade students at Rockyford School and any other district schools, regarding substance use. Motion carried, three voted yes, Conroy and Blue Bird voted no. (Attachment F)

0535. Girls' Society

Saunie Wilson, Wolf Creek Dean of Students, and Melissa Iron Cloud, Principal of Wolf Creek School, presented the concept of establishing a Girls' Society. The Society could initially assist approximately twelve to fourteen 8th grade student girls, for the purpose of providing talking-circle time and counseling services. Cost for this program would be \$5,000.00 for a sixteen-week period, September through May of the 2022-23 school year. Motion by Conroy, seconded by Eagle Bull to approve. Motion carried, four voted yes, Blue Bird not voting. (Attachment G)
