#### 0561. LTHS Work-Study Program

Lakota Tech High School Principal, Chanda Spotted Eagle, presented a proposal for a Work Study Program for high school seniors, which would provide part-time work for them while simultaneously providing them work experience in various fields. Seniors would work for approximately one and one-half hours per day, where appropriate. Motion by Conroy, seconded by Blue Bird to approve the Proposal. Motion carried unanimously. (Attachment F)

#### 0562. <u>Authorize to Advertise</u>
