#### C. ADMINISTRATOR'S REPORTS

#### **BUILDING PRINCIPAL'S REPORT:**

#### **Student Highlights:**

- The sophomores were the first in-person group to complete Mad City Money sponsored by CCE and Northern Credit.
- High school students were able to participate in a traditional Career Day with both inperson and virtual presentations by local professionals.
- The seniors were treated to goodie bags, pizza party and ice skating on the last remote learning day.
- HS juniors will have the opportunity to take the ACT and SAT this spring here at Copenhagen, for the first time.

#### **Administrative Highlights:**

- Conversation has begun in planning for this year's Academic Awards Ceremony.
- A new EDGE course through JCC, Chemistry 131, has been added to our course catalog, thanks to Mr. Cooper's efforts. If enough students sign up, CCS will be the first and only district to accomplish this offering.
- All teacher evaluations will be complete by spring break.
- The number of remote learners has decreased dramatically since winter recess.

# **ELEMENTARY PRINCIPAL'S REPORT:**

- It's hard to believe it's that time already, but planning for the 21-22 school year is underway. Teachers have been surveyed on the pros and cons of smaller class sizes and scheduling has begun.
- Mr. Carden and Mrs. Ratliff attended a Lost Boys seminar on the differences between boys and girls in the classroom. A few strategies were shared for making school more conducive to learning for boys.
- Mr. Williams and Mrs. Greene are providing enrichment opportunities for some of our higher achieving students.
  - Two groups of 4th graders are completing an animal research project using Ozobots to navigate a codable map of the report.
  - A group of 2nd grade students are completing an Engineering is Elementary project focusing on wind turbines.

- The North Country Family Health Center facilitated the distribution of oral hygiene kits for all students from Wee Knights through 1st grade. The kits included a toothbrush, toothpaste and flossers in fun, child friendly designs.
- Storybook Character Day is coming up on April 1st! Teachers and students alike can share their excitement for reading by dressing like their favorite character and sharing their favorite book.
- Elementary teacher interviews were held over the course of several days. 10 outstanding candidates were interviewed, and the hiring decision has been extremely difficult.
- Formal observations for all elementary teachers have been completed.
- Mr. Williams helped kick off 3rd grade's Vikings Quest by visiting the classroom dressed as Leif Erikson.
- Registration packets have been sent home to future Wee Knight and Pre-Knight students. We currently have the potential for 24 Wee Knights and 18 Pre-Knights.
- Mrs. O'Mara once again issued the Kids' Heart Challenge. Within one week of the kick off, students had already raised over \$3,000.

#### **D. SUPERINTENDENTS REPORT**

- ➤ COVID update we haven't had a positive case in 2.5 weeks, to date we have had 39 total. Lewis County last 14 day average was 3.8%; yesterday was 1.1% and it is trending in the right direction which is great. Over 80% of our staff has been vaccinated which will be helpful which is good we will not have to be quarantined if we come in contact with someone who is positive. The news is talking about changing social distancing from 6 feet to 3 feet and we will not make a change. In September, it will be beneficial to go inside 6 feet with the middle school, as it is a long day for them. We have used every inch of our building. There will be no changes for the rest of the year.
- ➤ There have been many discussions about what we are doing in the elementary next year. We have had three sections this year and we have learned many great things coming out of it with small classes sizes. It is our plan to stay in three sections in the elementary for the 21-22 school year. We would give up some AIS support but the kids are getting more out of a small class.
- ➤ Sports are continuing and some are overlapping this week, basketball, wrestling, cheerleading is continuing. Starting soccer and tennis this week.
- ➤ Project they are working outside again and working on the sound system as well as landscaping.
