This additional one-year extension to our current contract extends the contract through the 2025-2026 school year and amends the increase in route rates to account for driver wage increases and the company offering drivers health insurance as a benefit. Seconded by Director Bobbie Jo DeShon. Motion carried 7-0.

Director Tara Adkins made the motion to approve the 2021-2022 budget amendment presented in the board packet. This budget amendment is being made as standard procedure as the district is recognizing changes in revenues/expenses on the year and to help with budgeting decisions for the 2022-2023 school year. Seconded by Director Jesse Saunders. Motion carried 7-0.
