5 Project Update

Minutes:

Mr. Hoke reported there have been meetings held with the project architects and the design is 65% complete. The committee will meet next week to select design options. Required additions to the design will be a second stairwell and an elevator. Plans are to put the project out for bid in December. Mr. Sanders questioned what the time frame will be that the Fieldhouse will be out of commission. Mr. Hoke answered that the preliminary plan is to start the construction after basketball season and have it completed in the fall. There will be contingency plans for any construction delays.

6 Financial Report

Mrs. Laura Mullen, Corporation Treasurer

Minutes:

Mrs. Mullen reported the Education Fund is on target with expenditures, and the cash balance is a little higher than the benchmark. There was no activity in the Debt Service Fund. The Operations Fund is on target with expenditures. There was no activity in the Rainy Day Fund. The School Lunch Fund shows a negative in revenue due to a software issue with Meals Plus. They moved to an online hosted service and there is a glitch with the balances of free and reduced accounts. Shannon White is working to update student records electronically. August school lunch sales were higher than normal due to the glitch. Expenses in the School Lunch Fund are a little high due to catching up with summer invoices.

Mr. Graham reported that TCHS sports passes have almost sold out. They ordered 275 and there are 8 left. Three or four new big sponsors were added at the same time as sales for sports passes and that has added to the fund balance. Upcoming expected expenditures are fall transportation fees, new uniforms and windscreens.

Mr. Graham reported that the FTA football and cheerleading season has just finished. The 1st, 2nd and 5th grade teams won their championships. The basketball season will be starting soon. Plans are being discussed to possibly add two more low goals to the field house.
