Elementary Principal's Report
January 12, 2022

-Enrollment in PK-6th is 220.

-The library got a \$670 grant from Cooper Clark.

-We have had ten students and two staff members quarantined so far this semester. We have an elementary teacher in the hospital with COVID pneumonia.

-In addition to quarantine issues, we have had several students and staff fighting illness.

-The elementary basketball teams play Forgan at home tomorrow night, and the final game of the season is Monday at home against Tyrone.

-They are taking applications for after school tutoring in reading and math which will begin on January 24th. Elementary will have tutoring on Mondays after school until 5:00 PM. Ryan Buller set this all up and is in charge of the logistics, etc. I will have him report on the progress of this program once things are operational. I appreciate the time and great amount of work he has given to help our students get back on track academically.

Superintendent's Report
January 12, 2022

- We did get our checks from Texas and Beaver counties. Those were deposited yesterday. Beaver Co. – \$778,322.95, Texas Co. –\$ 230,630.62, Total - \$1,008,953.57

- We got a Mid-year adjustment. Initial Allocation - \$1,337,959.24, New Allocation - \$1,543,352.43. (+\$205,393.19). This allocation is what we get from the formula.

- DCP Tax Protest Update: Reports are due March 16, 2022. Discovery must be completed by April 27, 2022. Settlement conference date is April 27, 2022. Pretrial conference date is June 14, 2022. The trial date is to be determined at the pretrial conference.
