Board President, Sarah Doll appoint Roy Hawkins as Secretary Pro-Tem in the absence of Board Secretary, Ted VanKuiken.

Sarah Doll led in the Pledge of Allegiance.

**APPROVAL OF MINUTES:** Minutes from regular meeting dated February 15, 2021 and Mascot Committee meeting minutes dated February 24, 2021 were approved as presented.

#### ADDITIONS, DELETIONS & MODIFICATIONS TO THE AGENDA: None

#### **COMMENTS FROM GUESTS – AGENDA ITEMS:** None

<u>STUDENT EXPULSION HEARING:</u> Motion by Hawkins, supported by Elliott that the Saranac Board of Education go into closed session at 6:32 p.m. for the purpose of a student expulsion hearing, returning to open session at 6:45 p.m. Roll Call Vote: Yes – Courtnay, Doll, Elliott, Hawkins, Jackson, & Price. A board member reported on the potential of solar energy. The State is working on a template for an RFP (Request for Proposal).

One of the breakout instructional sessions was being virtually presented from our bus garage.
