April 19, 2023

Holly also explained we purchased the LifeVac anti-choking rescue devices to keep in the cafeterias and one in Nurse Holly's office. Holly explained what they were and what they were used for.

The digital Mammography Bus will be on campus May 18 and this is open to staff and the public. We also have the DSHS here to vaccinate Seniors that want to participate for college. We discussed that we still have the TCHATT in place and it is going well for our counselors. Mrs. Fuller with the cafeteria did not have any updates, Holly reminded the group that we will hand out flyers from the Texas Dept of Agriculture at the end of the year before Summer starts that will tell families where they can go for meals during the day. Mrs. Monk said she will have the Cancer Walk in May if anyone had anybody local they wanted to recommend fighting with cancer right now.

We left the meeting open to discussion. Mrs. Adams mentioned University of Texas at Tyler had free physicals this next weekend for UIL. Mrs. Caitlin Graham from the NETCAC said they are updating all of their curriculum and revamping their education. She is going to send me an updated list of all the services they can offer the school.

Our goal for next school year is to offer more of these services to our parents and students and we will renew our Wellness Policy at the first SHAC meeting next Fall. Mrs. Adams mentioned she was going to send over some resources to help go over the Wellness Policy.
