- 1. The meeting of the Board of Education was called to order by Board President Bob Soderberg in the County Line Elementary Cafetorium at 7:25 p.m. with the Pledge of Allegiance. Superintendent Brett Stousland read the official meeting notification. Roll call: Soderberg yes, Medved yes, Loth yes, Borden yes, Barney yes, Reinemann yes, Larson yes.
- 2. Motion by Larson, second by Reinemann to approve the agenda with item V.B. County Line Report moved to immediately follow agenda approval. Motion carried.
- 3. County Line grade 4 students gave a presentation on their experiences with Motion in Design and showed 3-D design projects they made to the Board.
- 4. Six district residents addressed the Board and/or read statements from others not present regarding racial issues in the District.
- 5. Motion by Larson, second by Reinemann to approve the February 22, 2021 Board of Education minutes. Motion carried.
