- 1. The meeting of the Board of Education was called to order by Board Vice President Sarah Larson in the District Performing Arts Center at 7:02 p.m. with the Pledge of Allegiance. Superintendent Brett Stousland read the official meeting notification. Roll call: Medved yes, Loth yes, Barney yes, Reinemann yes, Larson yes. Soderberg and Borden absent (excused).
- 2. Motion by Reinemann, second by Barney to approve the agenda. Motion carried.
- 3. District Resident Scott Hefle addressed the Board regarding the Ad-hoc Curriculum Committee, Board Happenings, committee meetings and the budget.
- 4. Motion by Barney, second by Reinemann to approve the February 22, 2021 Board of Education meeting minutes. Motion carried.
- 5. Director of Business Brittany Altendorf and Director of Human Resources Michael Nowak presented a COVID-19 expense report to date including PPE costs and personnel costs related to COVID-19.
- 6. Brett Stousland updated the Board on the Advocacy Council on Equity (ACE) and indicated it is a new committee working on equity, diversity, and achievement gaps and is still looking for members to add diversity to the committee.
- 7. Director of Teaching and Learning Brenda O'Brien updated the Board on a new high school English course for grades 11 and 12 that is being proposed and will involve manners of investigation and will include detective novels, investigative journalism, true crime, and will use logic, reasoning, investigative methodology, and teamwork to solve a mystery. - 16. Motion by Reinemann, second by Barney to approve continuing contracting with Dominiczak Therapy Associates, LLC for the 2021-2024 school years for OT and PT services. Motion carried.
