- 2. Motion by Larson, second by Spies to approve the agenda. Motion carried.
- 3. Motion by Larson, second by Spies to approve the March 18, 2019 Board of Education and closed session minutes. Motion carried.
- 4. Student Representative Avi Bhavsar reported on student activities taking place in the district.
- 5. MacArthur teacher Kim Whiting and a number of MacArthur students gave a Powerful Learning demonstration, showing experiments and offering examples of Growth Mindset in the classroom.
- 6. Performing Arts Center Coordinator Heather Pulkowski updated the Board on plans for the PAC/pool/field house grand opening celebration June 22, 2019.
- 7. School Board Clerk Lester Spies provided an election update.
