Unanimous Approval

Principal Norma Barber Reports

Maintenance duties assumed by employee Kari Keen. Created new agreement with Mrs. Keen as her current agreement is Cafeteria Cook ended June 10, 2020. The new agreement for maintenance effective June 10, 2020 through August 10, 2020. Chair Stacie moved to new business for discussion and vote.

School restrooms – girls and boys in main school building are currently being renovated with new partitions, flooring (girls), ADA compliant in both restrooms plus painting. Metcalf Contractors are researching 'fire door' between girls and boys gym bathrooms.

Measure 98 – delayed until August 31, 2020.

Weight Room – can begin with exception of some the weight equipment scheduled to be purchased with measure 98 funds.

Mr. Mulvihill reported the IMESD Board voted no to him becoming Ukiah School District Superintendent. Mr. Mulvihill presented four other possible acting superintendents working with Ukiah Principal, Norma. To-be-determined by end of July 2020.

Update – **New Small Thomas Bus** arrival has been moved from end of July 2020 to end of October 2020 due to strike in December 2019 and COVID-19 2020. The large Thomas Bus experienced a recall from factory overlooking the required knee padding behind each seat.

Camera – Chair Stacie Schock recommends the school purchase a camera to set on the shop focusing on the new school buses.

Old Business

Land/Dorm 215 W. State St. sale to Alex Allen and Morgan Tomilson (husband and wife) agreed to purchase of property with trailer (3) formerly called 'dorm' for asking price of \$60,000.00. The school board agreed purchasers could put \$12,000.00 down payment and \$400 per month with zero interest. The sale papers would be created by school attorney Mr. David Blanc. The sales agreement would be placed in escrow with Pioneer Escrow on or before July 19, 2020.

District House – For sale at \$120,000.00 asking price but no less than \$112,000.00. School Board agreed to wait until August 13, 2020 before placing on Craigs List.

New Business

Scroggins Scholarship Award – Student Quinton Orr requested to provide presentation to school board at August 2020 board meeting.

Teacher Application – John Basil-Young, Social Studies Teacher from Alaska interviewed with Principal Norma. Norma advised she would like to hire sometime in the future, Mr. Basil-Young currently is not in a hurry until he can be assured of permanent position with the school. Mr. Basil-Young also teaches cross country running, skiing and track.

George Murdock – Norma met with the Umatilla County Health Department among other superintendents and principals in Umatilla County. Mr. Murdock advised all schools have until August 31, 2020 to creat a plan for the County Health Department on opening their schools to students in August 2020. Suggestions: Classes 2020/2021 must work in cohort groups, cohort groups would be rquired to stay together throughout their school day. Few other examples: no water fountains, cohorts must eat together for breakfast (if served) and lunch, drink bottled water, limited and/or no sports but some physical excersize, etc.,.

Library Association – Norma will check their guidelines due to covid-19 as our library is both student and community.

Maintenance Agreement – Chair Stacie Schock motioned to approve employee Kari Keen’s maintenance duties agreement, seconded by Teddy Orr.
