## **Parking Pass Application 2023-24 School Year**

**Please note the following provisions if you are interested in applying for a parking pass at Midd-West High School.**

- The student parking lot is located off of Shuman Street and to the west of the main entrance of the High School; if/when each parking spot in the student lot is assigned, additional spots will be assigned in the lower tier of the faculty/staff lot adjacent to Rt. 522. SUN Area Technical Institute students will be assigned parking spots on the lower tier of the Rt. 522 side. **Students are not permitted to park in the spots on Wagenseller or Shuman Streets, in the Middleburg Elementary School lot or at the stadium.**
- Students must exit their vehicles and the parking lot immediately upon arrival at school and enter the building.
- Students are assigned parking spots and must display their parking permit on the rear view mirror of their vehicle; students must always park in their assigned spot.
- **Students choosing to not park on school property will not be permitted to leave school property to go to their car during school hours.**
- Administration reserves the right to revoke driving and parking privileges **based on inappropriate behavior or repeated tardiness to school.**
- Should there be the necessity of towing a vehicle from school property due to a driving/parking violation, it will be at the **owner's expense.**
- All rules of the Pennsylvania Vehicle Code apply to drivers and vehicles on school property.

Beginning July 10, 2023, please remit your application along with \$2.00. **Please have your license with you when you submit your application.** After approval by a building administrator, parking tags may be picked up at the high school office beginning August 7, 2023.
