# PUBLIC HEARING PART 1: PROPOSED SCHOOL BUDGET FOR FY 2021-2022

The School Board of the District has proposed a school operating budget for fiscal year 2021-2022. Pursuant to Order of the Governor, the budget meeting where these articles are presented has been replaced by a remote public hearing. The budget recommended by the School Board consists of the following Articles 1 through 14. Together, these articles constitute the proposed school operating budget for fiscal year 2021-2022 to be presented to the voters as Article 1 at a budget referendum election scheduled for June 8, 2021.

#### **ARTICLE 12:**

The School Board recommends that the District appropriate the amounts set forth below for the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act and raise and assess the amounts set forth below as each municipality's contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act in accordance with the Maine Revised Statutes, Title 20-A, section 15688.

State Mandated Explanation: The District's contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act is the amount of money determined by state law to be the minimum amount that the District must raise and assess in order to receive the full amount of state dollars.

## OTHER LOCAL TAX REVENUES FOR THE 2021-2022 SCHOOL BUDGET

ARTICLE 13: The School Board recommends that the District raise and appropriate \$3,102,598.67 in additional local funds, which exceeds the State's Essential Programs and Services allocation model by \$2,848,582.67 as required to fund the budget recommended by the School Board.

The School Board gives the following reasons for exceeding the State's Essential Programs and Services funding model by \$2,848,582.67: These funds are needed to fund costs of supporting four community schools that the Essential Programs and Services funding model does not recognize, to provide greater academic support in the form of educational technicians in District classrooms than the Essential Programs and Services funding model recognizes, to pay for co-curricular costs not recognized by the Essential Programs and Services funding model.

State Mandated Explanation: The additional local funds are those locally raised funds over and above the District's local contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act and local amounts raised for the annual payment on non-state funded debt service that will help achieve the District budget for educational programs.

## SUMMARY OF TOTAL 2021-2022 SCHOOL BUDGET

ARTICLE 14: The School Board recommends that the District authorize the School Board to expend \$26,824,000.00 for the fiscal year beginning July 1, 2021 and ending June 30, 2022 from the District's contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act, non-state-funded school construction projects, additional local funds for school purposes under the Maine Revised

state subsidy and other receipts for the support of schools.

Statutes, Title 20-A, section 15690, unexpended balances, tuition receipts.

# **PUBLIC HEARING PART 2: REFERENDUM ARTICLES**

The following school budget and other questions will be submitted to referendum on June 8, 2021:

**Article 1: School Budget**. Shall Maine School Administrative District No. 11 appropriate the sum of \$26,824,000.00 and raise the sum of \$10,607,598.67 for the 2021-2022 school budget?

School Board Recommends a "Yes" Vote.

### **VOTER INFORMATION FOR ARTICLE 1**

The Maine School Administrative District No. 11 school budget submitted in this Article 1 totals \$26,824,000.00. It includes locally raised funds in the amount of \$10,607,598.67, to be assessed in shares to member municipalities in accordance with the District's cost sharing formula and state law. The locally raised amount exceeds the State's Essential Programs and Services funding model by \$2,848,582.67. This budget includes these cost centers and amounts:
