

Includes: appropriations for mowers and tractors for B&G, utilities, legal fees for borrowings, printing supplies, and data processing services through BOCES. Additional programs were purchased to enhance the educational opportunities provided to the students.

Includes: the addition of 2 elementary teachers to reduce class size, 1 school psychologist, 1 high school guidance counselor, 1 ESOL teacher, 2 part-time IT technicians. Special education costs through BOCES and private placements are included here. The district reduced BOCES costs for psychology and ESOL services as demand for services exceeded BOCES availability.

## **Transportation** (**A5510 - A5540**)

The cost to purchase buses has been moved to the School Bus and Vehicle Capital Reserve Fund that requires voter approval (on the ballot for 5/18/21). Additional money has been allocated for contract transportation to cover out of district runs.

State aid is based on 2021-2022 foundation aid figures, building aid, and private and public cost aids based on data provided by state aid planning and the district's fiscal advisors. Although the district received a \$1.1M increase in foundation aid, building aid was \$2.5M less than 2020-2021 due to the change in long term debt.

## Federal Stimulus Funding

20% of the ARP funding, or \$2,142,502 must be used to address learning loss through the implementation of evidence-based interventions.

The United States Department of Education indicated that more detailed guidance on use of the CRSSA and ARP funds will be released in early May. The NYS Education Department, in conjunction with the NYS Division of Budget are working on applications that districts will submit on line through the Business Portal.

#### Bus Purchase & Vehicle Reserve

There will be a proposition on the ballot to approve the purchase of two 66-passenger school buses:

Proposition #2 - SHALL the Board of Education of the Gloversville Enlarged School District be authorized to expend up to \$261,581.50 from the District's existing capital reserve fund known as the "Bus Purchase and Vehicle Capital Reserve Fund" (as established by the vote of the qualified voters of the District on June 16, 2020) for the purchase of two (2) 66-passenger school buses, with all such vehicles to be used in the transportation program of the District, and with the result that such expenditure from the Bus Purchase and Vehicle Capital Reserve Fund shall have no impact on the tax levy of the District for the 2021-2022 school year?"

# **Summary of Total Proposed 2021-2022 Budget**

Total Proposed General Fund Budget \$67,262,883

If voters reject the proposed budget, the board of education may choose to adopt a contingent budget. There are three rules associated with a contingent budget:

- tax levy no greater than prior year
- non-contingent expenses removed
- compliance with Administrative Component
   Cap

An ordinary contingent expense is defined as an expense necessary to provide minimum services legally required to:

- operate & maintain school buildings & the educational program
  - preserve the property of the district
- ensure the health & safety of students and staff

A contingent budget for Gloversville will mean a reduction of \$172,546 in expenses.

Equipment is not considered an ordinary contingent expense, so the mowers and tractors for buildings and grounds would have to be removed and an additional \$122,546 in expenses eliminated.

Another contingent budget rule is the percent of the expenses attributed to the administrative component cannot exceed the prior year's (exclusive of capital).

2020-21 administrative component 9.38% 2021-22 administrative component 9.02%

This will remain the same even if a contingent budget is adopted.
