Federal funding for next year will be based on the 2019-20 free and reduced count.

COVID Funds

1st Round – Around \$20,000 is left. (started with \$84,196.02)

2nd Round – Around \$345,000 to carryover.

3rd Round – Should get around \$700,000.

The state cannot lower school funding because of these additional funds.
