- I. Meeting was Called to Order at 6pm and a Quorum was established with Emily Carelock, Grace Palculict, Johnny Morgan, Bonnie Fish, and Jason Hardy. Also present were Michael White, June Wells, Doug Smith, Carrie Burson, and Benita Jones.**
- II. Mr. Smith introduced Dr. Couture to recognize her drama students. Dr. Couture introduced Madeline Couture, Hannah Elizabeth, and Ellery Palculict for their accomplishments at the Arkansas State Thespian Festival.**
- III. Mr. Russel Gathright spoke during Open Forum on the topic of the Covid Protocol of wearing a mask. He asked the Board to consider removing that mandate.**
- IV. The Board unanimously approved the Transfer Request for Xaidyn Nelson to El Dorado School from Parkers Chapel School.**
