### **Curriculum, Instruction, and Assessment Highlights**

- State testing is underway, with math/ELA assessment in grades 3-8 and the third year of high school, and science assessment for grades 5, 8, and the third year of high school beginning next week.  
The math and ELA assessment is the NWEA, which is quite familiar to us. The science assessment is a new, lengthier assessment on a new platform (New Meridian); there have been a number of rollout hiccups across the state. I am encouraged that the assessment will address the NextGen Science and Engineering Standards, which we switched to in 2012, though I am concerned about the length of the assessment. Staff are understandably concerned about the dedication of significant instructional time in a disrupted year. I have encouraged our teachers to mentally approach this spring's rollout of the science assessment as a pilot, from which we can learn.

- Work continues on the details of a proposed OTHS Humanities Diploma.


### **ESEA programs (Title IA, IIA, IVA)**
