#### Part 1

A special meeting of the Board of Education of Arcola Community Unit District #306 Arcola, Illinois was called to order in the High School Library at 6:00 p.m. on Wednesday, April 28, 2021 for the purpose of Reorganizing the Board.

President Strader called the meeting to order. The following members answered roll call: Crane, Stout, Shonkwiler, Arrol, and Strader. Board member Wesch arrived later.
