This Agreement is made this 29th day of April 2021 by and between the Sharon Dunn ("Provider") and the Bishop Unified School District ("Recipient").

- 1. <u>Term.</u> This Agreement shall be effective for the 2021-2022 school year. This Agreement may be terminated by either party for any reason upon thirty (30) days' notice. Prior to the effective date of any termination, Recipient shall pay all amounts then due to Provider under section 2 hereof. Date(s) and location(s) for services are designated in "Attachment A".
- 2. <u>Payment for Services.</u> As payment for services performed under this agreement, the Recipient agrees to pay the Provider the amount of \$21,000.00 flat fee, due and payable within 30 days upon receipt of the invoice date.
- 3. Compliance with Law. Each party shall comply with all applicable federal, state, pand local laws, rules, regulations and ordinances; as such laws may change from time-to-time. Neither party shall unlawfully discriminate among persons covered by this Agreement on the basis of race, national origin, gender, age, creed, religion, marital status, sexual orientation, veteran status, disability, or any other basis prohibited by law. Each and every provision of law and clause required by law to be inserted into this Agreement shall be deemed to be inserted herein and this Agreement shall be read and enforced as though it were included therein.

## Miscellaneous.

- (a) Governing Law and Venue. This Agreement and the rights and obligations of the parties shall be construed and enforced in accordance with the laws of the State of California. The parties also agree that, in the event of litigation, venue shall be the appropriate state or federal court located in, California.
- (b) Severability. If any term or provision of this Agreement shall, to any extent, be held by a court of competent jurisdiction to be invalid, void or unenforceable, the remaining terms and provisions of the Agreement shall continue in effect.
- (c) Amendments. This Agreement cannot be changed or supplemented orally. It may be modified or superseded only by a written instrument executed by both parties.
- (d) Waiver. Any waiver of a term or condition hereof shall not be a continuing waiver of that term or condition.
