Mrs. Azevedo and Mr. Ehrler discussed being conservative with reclassification because of the new ELA testing standards and scores with the new CAASPP testing. At this time students will not be reclassification unless they meet CELDT criteria and score at a level 3 or 4 on the CAASPP. Mr. Ehrler stated that CDE is discussing setting a statewide criteria for reclassification.

Minutes:

1. Meeting was called to order at 8:23 am.
2. Minutes of the previous meeting (October 2016) were reviewed.
3. Mr. Ehrler reviewed the Consolidated Application for the 2017-2018 school year, identifying enrollment projections and data as well as federal funding eligibility.
4. Mr. Ehrler reviewed the Local Control Accountability Plan (LCAP) for the 2017-2018 school year. He summarized the goals and expenditures as related to schools' goals. He explained that increased Supplemental and Concentration funding this year and in following years has been determined by the community stakeholders to best serve the student population by eliminating combination classrooms. Mr. Ehrler explained that a new teacher has already been hired for 2017-2018 to split the 5/6 combination class and a modular classroom is scheduled to be installed.
5. Mr. Ehrler reviewed the Shiloh School District Parent Involvement Policy.
6. Miscellaneous/Other – Mrs. Rubio asked about CELDT testing during the summer (the scheduled time in past years). Mrs. Azevedo explained that the CELDT was being replaced by the ELPAC and except for initial testing (in the fall for students entering school in California for the first time), testing would now be administered in the Spring.
