The Hicksville Exempted Village Schools Board of Education met in regular session on Monday, March 15, 2021 at 5:30 p.m. in the Community Room. The meeting was opened by President, Jennifer Caryer, with the following Board members answering roll call: Minda Jones, Craig Eiden, Stephanie Mazur, Galen Methvin, and Jennifer Caryer.

The following items were discussed by the building principals.

The following were discussion items.

Mrs. Mazur asked about Growing God's Way (GGW) and their desire to create an instructional program. If the Board is to allow this Mr. Rick Straley, Chariman of GGW must understand that this must be an after-school program.

Mr. Eiden inquired if there are any Athletic Booster meetings coming up.... Mr. Slattery noted there weren't any scheduled at this time but will get some information out in order to schedule a meeting/s.

Mike Blue – Spoke about Mr. Countryman and the District's commitment to building positive relationships through communication thereby creating trust. He emphasized how he believes that there has been a lack of communication as of late and trust is being lost.

Dave Blue – Echoded Mr. Slattery's comments about self-defense courses. Also echoded Mike Blue's comments, says he's never seen anything like this go on.

Mrs. Caryer – Noted that processes and procedures are being developed to improve communication. Secondly, personnel matters will not be discussed in a public session.....emphasizing that we will not be addressing employment issues in public.

Mrs. Caryer noted that the Board appreciates people coming to our meetings.

Minda Jones moved and Galen Methvin seconded the motion to hold an executive session at this meeting in order to consider the appointment, employment, dismissal, discipline, demotion, or compensation of a public employee or official, or issuing suspension, or termination of a license, or the investigation of charges or complaints against a public employee, official licensee, or regulated individual unless the public employee, official, licensee, or regulated individual requests a public hearing.
