Notice is hereby given that sealed bids will be received at the Office of Purchasing, Marysville School District, 4220 80th St NE, Marysville, Washington 98270, for the Marysville Pilchuck High School Cafeteria Demolition Project. Bids will be received on Form of Bid until **2:00 PM on Thursday, June 10th, 2021** stamped in and held. Bids will be opened and publicly read following the time set for receipt of the Form of Bid.

Estimated construction cost: \$ 1.7 million.

A voluntary Pre-Bid Conference (highly recommended) will be held at Marysville-Pilchuck High School 5611 108th Street NE (project site) on May 26th at 3:00 PM, to answer any questions and review the scope of work in the documents. Following this meeting, a tour of the site will be given.

A Public Works Performance and Payment Bond in the amount of 100 percent of the Contract is required for this work. Each bid must be accompanied by a certified check, cashier's check, or Bid Bond of a duly licensed bonding company, in the amount of 5 percent of the Base Bid plus Additive Alternate Bids, made payable to Marysville School District.

It is imperative that the submitted bids are carefully analyzed and include the required information.

The Marysville School District reserves the right to reject any and all bids and to waive any irregularities or informalities. The right is reserved by the Marysville School District to postpone contract award for the period of thirty (30) days after the bid opening. No bidder may withdraw the bid after the hour set for the opening thereof, or before award of contract, unless said award is delayed for a period exceeding thirty (30) days.
