- The Interim Superintendent reported that the water line at the Gibson School has failed. After due deliberation, and on motion by Mr. Chris Olds, seconded by Mr. Brian Burton and carried 5-0 it is:
- **RESOLVED**, that the Board of Education finds the failure of the water line at the Gibson School creates a danger to District property, and threatens the health of the children and adults assigned to the Gibson School building, it is further
- **RESOLVED**, that the water line should be repaired on an emergency basis, and it is further
- **RESOLVED**, that pursuant to General Municipal Law § 6-d an amount not to exceed \$40,000.00 shall be expended from the District’s Repair Reserve fund for the purposes of repairing the water line. The monies expended shall be returned to the fund in accordance with law.
