BUS SAFETY PROGRAM

Park County School District 6 is committed to offer safe transportation to all students following the outlined conditions.

Responsibilities of the driver are to:

1. Provide at all times for the safety and welfare of the students assigned to their bus.
2. Know their student passengers and permit only authorized persons to ride in the bus.
3. Provide a clean and sanitary bus.
4. Obey traffic laws and driving regulations.
5. Follow as rigidly as conditions will permit the regular time schedule.
6. Be in control of the bus and passengers at all times.
7. Enforce the regulations of the Board and administration.
8. Report all infractions of the rules to the appropriate principal.

Responsibilities of students and parents are to:

1. Be ready to board the bus on time.
2. Be careful in approaching the school bus stop. Wait until the bus is at a complete standstill before attempting to enter.
3. Remain off the road at all times and behave in a safe manner while waiting for the bus.

Student's must observe the following safe riding regulations:

1. Follow building specific Code of Conduct
2. The bus is an extension of the classroom.
3. Avoid unnecessary noise which might divert the driver's attention and cause an accident.
4. Never stick hands, arms or any other part of the body out of windows or doors.
5. Pay for damage intentionally caused to seats or other interior parts of the bus.
6. Never experiment or tamper with the bus or any of its equipment.
7. Be careful not to leave lunches, clothing, books, etc. in the bus.
8. Keep personal possessions out of the aisle.
9. Never throw anything in the bus or out of bus windows.
10. Remain in assigned seats until the bus has stopped.
11. Assist in keeping the bus as safe and sanitary as possible at all times.
12. Be courteous to fellow pupils and the bus driver.
13. Remain quiet when the bus is approaching a railroad crossing and until the bus has passed the crossing.
14. Obey the school bus driver and, in case of emergency, remain in the bus unless otherwise instructed by the individual in authority.

15. Never smoke or vape on a school bus.
16. Remain seated while the bus is in motion.

It is the student's responsibility upon leaving the bus to:

1. Help look after the safety of smaller children.
2. Be careful and watch for traffic.
3. Cross 12 feet from bus when crossing road after departure, and look both ways to make sure no traffic is approaching.
4. Get off at the designated stop unless parents have arranged with the driver through personal contact or written request for departure from the bus at some other place.

In case of serious infractions of the rules, the driver will notify the Transportation Director. The Transportation Director will work with the building principal to determine the age and action specific consequences including up to being suspended from riding the bus. The District will notify parents/guardians of a serious infraction.
