SUPERINTENDENT'S REPORT

Our monthly spreadsheet shows that the 3rd quarter mandated categorical payments were due in March and have not been paid. The state owes the District \$111,668.79 in special education, driver's education, early childhood and transportation funds. As the legislature is in full swing, a number of unfortunate bills have popped up that we are keeping an eye on – some are good, but more are bad. There are currently 24 bills in the House and Senate that will change the curriculum for each District in the state, some even contemplating reaching K-12. These include the following: Home Economics, sex education (includes sexting), medical and legal ramifications of cannabis, K-12 required reading books for all kids on racism, financial literacy (JH), media literacy, Spanish, Asian-American History, work ethics and career explorations starting in 6th grade, how to act during traffic stops, gun safety, include e-cigarettes in health classes, establishing physical boundaries in sex education class, requires certain required reading material be authors by blacks, women, Native Americans, Asian, or Latins, unit on human trafficking, a unit of instruction on how to become a U.S. citizen, and finally a unit of study on Muslim Americans. Other legislation being considered is consideration for changing the special education age from 21 to 22, providing menstrual hygiene products for all starting in 4th grade for boys and girls restrooms, a

requirement for all Districts to develop a sexual misconduct code, gender-based violence legislation, school board members must have a trauma-informed course.

The security system and updated intercom system at North has been ordered. Electrician is working on price quotes for rewiring the stage. Plumber is working on price quotes for hot water on east side of HS building -1st floor. All of the duct work and air quality work has been ordered and will start work in July. We have met with the architect and CM on the kitchen remodel as well as a kitchen designer. We should be getting some drawings soon.
