High-Tech Security Features

**1. Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.**

The Smart Schools Bond Act monies will be used in multiple ways to improve security throughout the two school buildings. Existing analog cameras will be replaced with IP based digital cameras and associated video management systems. Access control systems will be provided at exterior doors with associated servers. In the original plan a new secure entry vestibule was planned to be provided at the Middle/High School along with a relocated Main Office to control visitor access. Unfortunately, the bid prices were excessively above budget and this component of the plan had to be moved to a future capital project.

The district is proposing to reassign the Capital Intensive funds to additional Electronic Security including additional video security and improved emergency communication.

The district is proposing to replace the existing emergency communication system at the high school to an IP based system. This system will eliminate "dead areas" where the existing analog system has failed.
