Program Director's Updates

Technology Coordinator

Larry Williams presented to the board on ECESC website Google search performance for February, SpendBridge reports on first quarter spending for 2020 (\$98,800.88) and 2021 (\$115,113.76), and current paper prices through Office Depot (\$29.99/case) and CMP (\$26.88/case/skid & \$25.72/case/truckload). He informed the board that paper prices will be going up at the end of March.

Instructional Program Report

- Keep Indiana Learning and local PD Region 4 is the biggest user of Keep Indiana Learning
- Affinity Groups groups and participation continue to grow
- Title III Grant professional development numbers are too low to run workshops but the good news is schools are learning a lot more about their Title III program
- GEER Grants
 - ESC Collaborative five member schools are participating
 - 2. IU East Partnership teachers from member schools getting graduate certificate
- Educational Solutions
 - Hazel free to districts bills medicaid (telehealth services schools can have in their nurse clinic)
 - 2. EdConnective instructional coaching for schools
 - 3. Apptegy ADA compliant mobile app and website for schools

Executive Director Report

- Meeting with Legislators met with Mr. Prescott and Mr. Raatz recently to talk about electricity restructuring and ECESC services provided to schools
- Covid-19 SBA Relief Funding ECESC qualifies for the Payroll Protection Program (PPP) loan – the board agreed that the Service Center should apply for this forgivable loan and start the process of getting 501(c)(3) status
- Classroom Connection updates and discussion on the teacher sharing program – the board offered thorough feedback on this topic
 - 1. Roundtable through CELL
 - 2. ACP with IU
 - 3. Approximately 9 semi-committed to teaching
- Bus Driver Certification Program have been talking with Ivy
 Tech to see if they could help with the CDL portion of the

program – Ivy Tech will not be an option for the CDL because of the cost

- George and Francis Ball Foundation wants Service Center to collect data from member schools
- Muncie By 5: An Early Childhood Initiative Director of Muncie By 5 wants the Service Center to be a vendor for her grant – this grant will service all the Delaware County early childcare centers – the board agreed to charge Muncie By 5 \$4.00 per ADM

A motion was made by Mr. Hunter, seconded by Mr. Black, to approve Muncie By 5 as a Partner member of the Service Center. The motion carried unanimously.
