## **REDUCTION OF BOARD SEATS – Action 20-157**

Motion by J. Butler, and seconded by R. DiGilio, to approve the following resolution regarding the number of seats on the Franklin Township/Warren County Board of Education:

- **WHEREAS,** the Franklin Township Board of Education has recognized that the number of individuals submitting petitions to be placed on the election ballot for Board of Education seats has declined greatly over time, and
- **WHEREAS,** The Franklin Township Board of Education occasionally experiences difficulties in maintaining full membership and/or meeting quorum, and
- **WHEREAS**, many school districts of similar size to Franklin Township have transitioned to Boards composed of seven members,

**THEREFORE**, the Board of Education resolves to submit a special ballot question to the voters of Franklin Township, in November of 2020, that, if passed, would reduce the number of seats on the Board of Education from 9 (nine) to 7 (seven), under the transitional protocols established by the State of New Jersey, and that said question and interpretive statement shall appear on said ballot in the following format:

Question – Should the membership of the Franklin Township Board of Education, in the County of Warren, be reduced from 9 (nine) members to 7 (seven) members?

Interpretive Statement – The Franklin Township Board of Education has had 9 (nine) members, since its inception, while many Boards in communities of similar size are finding it beneficial to reduce their size to 7 (seven) members. This reduction aids in meeting the challenge of maintaining a full board and assisting to achieve quorum at meetings, particularly since all members serve in unpaid positions.
