Early Reading First Program: LEAP Grant (Ref. 4)

Superintendent's Reports

Partial Day Program (PDP) Report (Ref. 5)

Mr. Forman and Dr. Levine provided information on the Windham Partial Day Program (PDP) housed in the EASTCONN facility on Route 66 in Columbia. Mr. Forman explained that the purpose of this program, which was established in January 2004, is to provide a cost effective alternative to homebound instruction while giving students a quality education. This program services many of Windham's expelled students and some students who have chronic non-attendance issues. At the present time, there are thirteen students enrolled in the program which runs from 3:00 PM to 6:00 PM from Monday through Thursday. Core academics and technology education are offered and transportation is provided at no cost to the family. Students accumulate high school credits and may graduate from Windham High School. Clinical services are also available. Mr. Forman and Dr. Levine answered Board members' questions. They were thanked for the information presented at tonight's meeting.

Staff and Student Recognition (Ref. 6)

Mr. Perzanoski announced with pleasure that Natchaug Principal, Rose Bisson, has been invited to serve

on the newly established advisory board of the School of Family Studies at the University of Connecticut. He also was pleased to announce that Windham High School and Arts at the Capitol Theater (ACT) creative writing student, Chelsea Love, has won the IMPAC-Connecticut State University Literary Award for Young Writers for her poetry and will represent Windham County in the state contest in June. Mr. Perzanoski and the Board congratulated both Mrs. Bisson and Ms. Love.

Financial Statement (4/30/05) (Ref. 7)

Mr. Nelson reported that the line item on the April financial statement for special education tuition indicates that the amount is down about \$30,000. The excess cost special education reimbursement is being cut about \$45,000. However, he said that the budget for this year is still on track. There were no questions.
