# Superintendent's Reports

# Forty-five Day Review of District Improvement Plan (Ref. 5)

Mr. Perzanoski explained that a formal forty-five day review of the District Improvement Plan, which was presented to the Board last spring, is required by NCLB. Another update will take place in February with a formal review in June. Mr. Perzanoski reviewed the plans for Windham High School and Windham Middle School and answered questions from the Board throughout his presentation. Dr. Anderberg reported on the Reading First Roll-Out initiative at the elementary-school level and also answered questions. Mrs. Kiss and Mr. Giordano were present and commented on the program. Dr. Summa spoke about professional development in the district as it relates to curriculum and instruction and answered questions throughout her presentation. There was discussion regarding grouping and Mr. Folan and Mr. Perzanoski said that this topic would be brought to committee for discussion. Mr. Stover reported on the Before and After School Program and parental involvement portions of the review. He also answered questions.

# Staff Recognition (Ref. 6)

Mr. Perzanoski recognized Windham High School math teacher, Christine Maclure, for her nomination by a student to apply for the Disney Teacher Awards. The Board and Mr. Perzanoski congratulated her and wished her well throughout the rigorous application process.
