Section 1. The Board hereby rescinds its suspension of public participation.

Section 2. Community members wishing to address the Board of Education may do so in person and must follow all health and safety protocols of the Board while on its premises. Only one public participant will be permitted into the meeting room at a time. In accordance with Board policy, each statement made by a participant shall be limited to 3 minutes duration and the entire public participation portion of the meeting shall be no more than 30 minutes, unless extended by a majority affirmative vote of the Board. Only ten total persons shall be permitted to be present in the meeting at one time.

Section 3. This Board of Education hereby finds and determines that all formal actions relative to the adoption of this resolution were taken in an open meeting of this Board of Education; and that all deliberations of this Board of Education and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.
