### 1. Opening and Announcements

**2.1.** Arizona School Boards Association will present the Governing Board with the results of the community on-line survey related to the position of District Superintendent.

Superintendent Survey 2014. Mr. Highlen reviewed the responses from the community and staff for the survey questions.

**2.2.** The Governing Board will discuss and possibly consider the contents of the position pamphlet that will be used to advertise the position of District Superintendent.

Mr. Highlen provided the information related to the advertising pamphlet for the position of Superintendent. The Board members discussed the results of the on-line position survey and information provided by Mr. Highlen.

- Board meeting on Tuesday, March 25, 2014 at 8:00 am in the Boardroom. Board members will review and screen applicants and determine which applicants will be asked to interview. Mr. Highlen will contact the applicants and set up interviews.
- Board meeting on Tuesday, April 2, 2014 to interview the candidates.
- **2.5.** Arizona School Boards Association will present the Governing Board with information related to the application process for the position of District Superintendent.

Mr. Highlen mentioned that ASBA will coordinate all aspects of the application process.

**2.6.** The Governing Board will discuss and possibly consider the addition of up to two District specific questions to be placed on the position application for District Superintendent.
