## **KINDERGARTEN MEDICAL REQUIREMENTS**

Welcome to Kindergarten! This will be an exciting, fun-filled year for you and your child. This note is to inform you of the requirements for students entering Kindergarten. In order for your child to be in compliance with state law, the school nurse will need the following:

- ☐ Physical Exam – Must be completed on the State of Illinois Child Health Examination form(DHS)
  - ☐ Diabetes Screening – Questionnaire on exam form to be completed by the physician located on the State of Illinois Child Health Examination form
  - ☐ Lead Test – Required for all children 6 months to 6 years
  - ☐ Health History - parent to fill out on the back of physical
- ☐ Immunizations:
  - ☐ Diphtheria, Pertussis, and Tetanus – A series of 4 or more doses, with the booster dose given on or after the 4 th birthday
  - ☐ Polio – A series of 3 doses or more with the booster dose being given on or after the 4th birthday
  - ☐ Measles, Mumps, and Rubella – Two doses required
  - ☐ Hepatitis B – Three doses required
  - ☐ Varicella (Chickenpox) – Two doses required
- ☐ Vision Exam – Due by October 15th of the Kindergarten year
- ☐ Dental Exam – Due by May 15th of the Kindergarten year

### **\*\*STUDENTS WHO ARE NON-COMPLIANT WILL BE EXCLUDED ON OCTOBER 15TH\*\***
