5.10. Approval of School District Excess Utilities Report and expenditure Plan for 2008-2009 school year.

A district may budget for utility costs that are exempt from the Revenue Control Limit, as provided in A.R.S. §15-910. Excess utilities are direct operational costs of heating, cooling, water, electricity, telephone communications and sanitation fees that exceed a base amount. The base amount is calculated by increasing or decreasing the utilities cost for the base year of 1984-85 by the percentage change in the combined Revenue Control Limit and Capital Outlay Revenue Limit from the budget year. A district may expend from the excess utility budget category only after it has expended the full amount budgeted in the base utility lines of the budget. The amount budgeted for excess utilities may be revised, after notice is given and a public meeting is held, any time before May 15, 2009 The ability to budget for excess utilities ends after FY 2009-20010.

Dr. Rutan explained the grant is for SMS and is an after school program. The facilitator will be paid out this grant.

Mrs. Arvizo mentioned that this is two hours daily after school and is limited to 6th, 7th and 8th graders. 130 students will benefit from this program.

Mr. Moreno asked for how many years.

Mrs. Arvizo mentioned that this grant is for 3 years.

Mrs. Camacho asked if this program is only for those that are low.

Mrs. Arvizo mentioned that is program is for all student grade levels.
