Board of Education Awards - Mr. Burk

Special Education

Special Education Update - Mrs. Finnigan

Mrs. Finnigan began her presentation with Special Education Facts and Figures, comparing where the District is going and where the District has been over the past few years with our

services. Student Placements, Classification Rates and Graduation Rates show a similar or increased improvement in data as Batavia strives to keep our kids in the least restrictive environment. Administration continues to be effective at targeting all available services for standard classification rates for students with disabilities. We continue to provide feedback to the NYS Education Department at every opportunity about extended graduation rate requirements for these individuals. Currently, the existing process we use does not count towards District scores with the State Education Department. Our focus remains on student completion and passing rates. Last school year, the district participated in the Special Education Indicator 8 Survey for our classified students. SED results from this survey will be provided between November 2017 and January 2018.

Nutritional Services Update – Mrs. Presher

Mrs. Presher, being new to the district as Nutritional Services Manager for the Genesee Valley Educational Partnership since mid-year last school year, introduced herself and provided a brief biography. She is glad to be here in Batavia and has spent time getting to know the administration and staff. She shared current responsibilities and new programmatic changes introduced in our School Lunch Program. She also works closely with all four building administrators to assist in services requested at the schools. Highlights were shared with the most accomplished enhancement being lead sponsor for the Summer 2017 Feeding Program. Mrs. Presher provided nutritious snacks and meals to BCSD Extend-ed Year/TEAM Literacy, Niagara County Youth Board and the Batavia Youth Bureau to pro-vide breakfast and lunch during the 6-week programs. Positive feedback was received throughout. Goals established for the 2017-18 school year include the return of catering with a new menu options slated to launch shortly, use of Google Docs for recordkeeping, and the commencement of electronic timesheets. The new District Charge Policy is now in place and a review of ways to recover existing lunch charges is in the forefront for discussion. Mrs. Presher thanked the Board for their support.
