Preliminary Budget Overview - Mr. Rozanski

Mr. Rozanski provided a brief summary of the first draft of the 2018-19 proposed budget. Several factors still will affect the budget such as retirements and State aid figures. A more structured proposal will be presented at the next Board of Education meeting on February 27, 2018. Currently, salaries are up but there is a decrease in the Debt Service Fund (net budget increase of \$752,000). The Debt Service expenditures are included in the General Fund for the second year. Potential initial adjustments to the budget will include accounting for retirements, health care, State Aid and the Teachers' Retirement System rates. The preliminary budget at this time without any adjustments is \$50,622,591 which is a \$752,006 increase, or 1.51% over last year's budget. The Preliminary Property Tax Levy is \$19,673,927 or an increase of 6.34%. This is currently below the tax cap. The District has changed our philosophy with debt services and the impact it has to the budget this year. The change was to comply with the NYS Comptroller's recommendations. April 10, 2018 is the latest scheduled Board of Education meeting to adopt a budget. Two Budget Ambassador sessions have been held, with the final meeting reserved for detailed revenues, tax cap discussion and long-range planning.

Mr. Burk and Mr. Dailey attended the Genesee Valley School Boards Institute Legislative Breakfast this past Saturday, February 3, 2018, at Geneseo Central Schools. Mr. Dailey led the discussion with Assemblyman Hawley. He is doing all he can to help us.

Mr. Dailey, Chief Heubusch and newly trained BHS Alum Officer Lawrence discussed bringing DARE back to Batavia CSD. DARE has evolved to stand for Define Assess Respond Evaluate. We will implement the DARE Program for all 5th graders in 2018-19. This is a 10-week course that each student participates in during the year, when up and running. Mr. Dailey is very excited to have this resource for our students and families. It fits well with our character education programs, too.

Budget Ambassadors have met twice for assisting with the 2018-19 Budget. We have a great group of citizens asking questions and getting to know our practices. We have one more session next Monday night. Thank you to our student ex-officio for attending last night.

The Legislative Advocacy met with representatives in Albany twice in January with Small City Schools and the Genesee Valley Educational Partnership Chief School Officers' Legislative Committee. Our representatives all state that they are going to be doing all they can for our district. Mr. Dailey will keep the pressure on.
