District Technology Update - Mr. McKinney

Tech Update

The technology update began with facts and figures regarding websites utilized by our students on Chromebooks, technology protected by iBoss and GoGuardian, active Google Classrooms, the number of documents generated monthly, the technology backup system, and the decrease in repairs as students learn to care for District-owned devices. This information is proof that the Informational Technology Department, under the direction of Mr. McKinney, supports our curriculum to its fullest, and is a forerunner with the latest equipment and security available to users in the region. Students are becoming much more proficient with their use of a variety of technology tools.

STEAM Labs, Robotics and Chromebooks are a major part of our educational learning process. Mrs. Calandra, Ms. LaGreca, Ms. Martell and Ms. Shuskey, along with the assistance of students Pheobe Beal, Brock and Ryan Bigsby, Landon Hamilton, Ella Shamp and Tosh Spilberg, explained and demonstrated the numerous devices and projects created through the STEAM Lab, 4th Grade Innovators, Media Center, ACE, WIN Groups and in the classrooms throughout John Kennedy Intermediate. Hands-on demonstrations allowed participants to explain the planning and development process used to create their interactive device. Math, Reading and Social Studies lessons are enhanced across the curriculum to provide a structured learning environment. Student Websites, Google Suite and Google Classroom allow these young innovators to share their experiences across the nation electronically.

Preliminary Budget Overview - Mr. Rozanski

Financial figures in the second draft of the 2018-19 proposed budget reflect adjustments due to additional retirements and expenditure modifications. State aid figures have not yet been released which impact adjustments to revenue. Currently, there is a 4.46% Tax Levy increase which is under the 7.17% tax cap. Expenses are down as Mr. Rozanski continues working to reduce the Tax Levy. By keeping the Tax Levy under 3%, there should be little or no impact to homeowners as a result of complying for the tax rebate check since we are under the tax cap. Mr. Dailey stated that long term, we need to forecast our Tax Levy each year basing adjustments on the Debt Services offset. Total expenditure adjustments to the budget as of February 27, 2018 reflect a decrease of \$347,060.00. We await final aid figures from the State but can only estimate expected support as true aid figures usually arrive toward the end of the calendar year.

Buildings and Grounds - Mr. Dailey

The committee met for an update on the 2020 Vision Capital Project. All paperwork has been submitted to the NYS Education Department; pre-screening has been applied for. The anticipated goal is for groundbreaking in the Fall, 2018. Mr. Ganino has requested permission for use of new style soap dispenser on a trial basis. The committee has approved this product.

BCSD Foundation, Inc. - Mr. Dailey

Fundraising efforts through the Districtwide Can and Bottle Drive are underway. Trailers will be placed at each building, assigned weekly, for collections. The location with the greatest amount of donations collected will be awarded \$100.00. Information and literature for Golden Apple Awards and Memorial Pavers at the stadium are being reviewed. A scholarship will be awarded annually by the Foundation; criteria has been developed and will be presented to the School Board for approval next month.

Safety Committee – Mrs. Bromley

With the latest school shooting incident, the Safety Committee discussed the following topics at their last meeting: a 911 press release through the Sheriff's office, policy review for wheelchair bound individuals, threats, fire drills. There is a lot of talk about arming school personnel and armed security guards on campuses. The District has not considered arming staff at this point in time. More review is needed in order to further rdiscuss additional options to our safety programs.

Mr. Dailey stated that, due to emerging school shooting situations, additional preparedness drills may be scheduled. He has also been working with Chief Heubusch for consistent police presence at all District buildings. We continue to take a proactive approach by allowing police access to all buildings and continue thorough investigations when any type of threat is made districtwide. Mr. Dailey indicated that we have applied for grant funding for the past three years to support School Resource Officers, but fortunately, we do not qualify based on the number of serious situations we face. This is a good thing. He also explained that, besides budgetary constraints, the process would take 6-8 months to train, interview and employ them. The Batavia Schools sit right in the middle of the NYS Troopers Barracks, Genesee County Sheriff's Office, the Batavia Police Department, and have a uniformed officer directly across from the High School at the Genesee Valley Partnership. Furthermore, we currently employ three retired members of the police force.

The Safety Committee also discussed: security camera upgrading to include full-area viewing at all entrances, upgrades to all interior door locks, training sessions for new hires, mental health awareness, lockdown drills, and continued talks with legislation on school safety issues by the Superintendent, Board of Education and Administration.

A letter was sent to all parents reinforcing our commitment to safety to all district parents last Friday. As a reminder, we are upgrading all cameras and locks districtwide with the Smart Schools Bond money and will be making the entrances to buildings more secure with the 2020 Vision Capital Project, as well.

Mr. Burk attended two events as he continues to work with Legislation for the betterment of our schools.
