## Board of Education Awards - Mr. Burk

The Board recognized the following individuals for their hard work, positive attitude and continued support to the faculty, staff and administration of the Batavia School District. Jessa Stewart and Evan Patric received Outstanding Student Awards, and Ann Baehr was given an Outstanding Staff Member Certificate. Mr. Burk, on behalf of the staff and administration, commend them for Taking Care of BCSD.

## Budget Hearing - Mr. Dailey and Mr. Rozanski

Mr. Dailey began the 2018-19 budget presentation with data on student enrollment, staffing, the District Graduation Rate (89%), and Graduation Rate (92%) and Completion Rate (91%) for Batavia High School. The proposed 2018-19 budget allows for New York State non-mandated programs that the Batavia Community have supported in the past and continue to support for our entire student population. Some of these programs include Gifted and Talented Education at the elementary level, accelerated classes for the Middle School students, Advanced Placement and Courses for College Credit for High School students, safety and security upgrades in all buildings and a \$100,000.00 Capital Outlay Project for Jackson Primary allowing for more "green" lighting.

Mr. Rozanski continued the hearing with an explanation of the Tax Levy and how it helps to balance the budget after expenditures, revenues and appropriated fund balances have been finalized. Furthermore, the residents of the District, as a result of District Compliance with the NYS Tax Cap, will again qualify for a tax rebate which will be paid directly to the taxpayers from the State of New York. This is a tax rebate paid back to the taxpayers for the 5<sup>th</sup> consecutive year. The District's proposed Tax Levy increase for 2018-19 is 2.4%. The seven-year average Tax Cap allowable increase is 3.84%. The proposed 2018-19 Budget is set at \$52,189,152.00. Polls will be open from 7 AM to 9 PM on Tuesday, May 15, 2018, for residents to cast their votes on the 2018-19 Budget proposal, election of three Board of Education Members (unopposed) for one 3-year, 46-day term, and two 3-year terms, and the approval of a Student Ex-Officio Board Member position (required bi-annually).

# RESOLUTION REGARDING STATE ENVIRONMENTAL QUALITY REVIEW

WHEREAS, the Batavia City School District (the "District") Board of Education has determined to proceed with a 2018-19 Capital Outlay Project to address the following Scope of Work:

The District's existing Jackson Primary building mounted lighting consists of HID flood lights and some rectangular recessed compact fluorescent fixtures mainly provided under canopies around the building. All building mounted lighting will be replaced in-kind with LED fixtures maintaining the existing wiring and mounting methods. All brackets will be reused for new fixtures as required. The existing parking lot is presently illuminated by drop lens cobra head type and shoebox type HID pole mounted luminaires. All HID fixture heads will be replaced with LED luminaires, with lumen output and optics determined as required to maintain existing fixture and pole locations and provide IES recommended minimum lighting levels. All exterior lighting will be automatically controlled with photocell override. Additional related work will be performed as needed.

WHEREAS, the Board has reviewed the scope of the project and has further received and considered the advice of Wendel WD Architecture, Engineering, Surveying & Landscape Architecture, PC with respect to the potential for environmental impacts resulting from the proposed action; and

**WHEREAS**, the Board has reviewed the Proposed Action with respect to the Type II criteria set forth in 6 NYCRR part 617.5(c), now therefore;

**BE IT RESOLVED**, by the Board of Education as follows:

- 1. The Proposed Action does not exceed thresholds established under 6 NYCRR Part 617, State Environmental Quality Review Act, (SEQRA).
- 2. The Board hereby determines the Proposed Action as a Type II action in accordance with the SEQRA regulations.
- 3. No further review of the Proposed Action is required under SEQRA.
- 4. This resolution shall be effective immediately.
