1. Public Hearing

2.3. Comments from the Audience

Under Comments from the Audience, the public may address the Board on any subject not listed on the agenda. An individual may only address the Board once under this item. Three (3) minutes may be allotted to each speaker but can be extended by a Board member, if so desired. The Board cannot act on non-agenda items and cannot respond to issues other than to provide general information or giving direction to the Superintendent to add to a future agenda or for the Superintendent to follow up with speaker. The individual shall state his/her name and address before addressing the Board.

Mr. Heredia announced to the audience that Mr. Michael Warren wanted to address the public. Mr. Heredia mentioned that the Board cannot act or comment on the issues and also that the individuals shall state their name and address before speaking.

2.4. Call for Executive Session A.R.S. §38-431.03 (A.1)

Discussion or consideration of employment, assignment, appointment, promotion, demotion, dismissal, salaries, disciplining or resignation of a public officer, appointee or employee of any public body, except that, with the exception of salary discussions, an officer, appointee or employee may demand that the discussion or consideration occur at a public meeting. The public body shall provide the officer, appointee or employee with written notice of the executive session as is appropriate but not less than twenty-four hours for the officer, appointee or employee to determine whether the discussion or consideration should occur at a public meeting. A.R.S. §38-431.03 (A.3) Executive sessions discussion or consultation with the attorneys of the public body in order to consider its position and instruct its attorneys regarding the public body's position regarding contracts that are the subject of negotiations, in pending or contemplated litigation or in settlement discussions conducted in order to avoid or resolve litigation. 3. Reports/Discussion Items

3.1. Superintendent

3.1.1. Mr. Michael Warren

Dr. Rutan reported the highlights of the following items:

- Trip to Washington D.C. with the Family Literacy group. What a great experience it was for those eleven ladies that traveled there for the first time.
- Red Ribbon Parade he praised the students and schools for their participation and especially the Somerton Middle School band for their performance.
- He thanked Mr. Jerry Cabrera for a wonderful job of organizing the event.

Dr. Rutan made the following statement to the Governing Board:

Although this is not the time or place to discuss allegations or ask questions about Mr.Warren (6th Grade math teacher at Somerton Middle School), because this will be determined with legal counsel, we are informing the board that we will be bringing a statement of charges to dismiss Mr. Warren for alleged multiple gross acts of insubordination and unprofessional conduct. Additionally, we believe Mr. Warren has used students in an inappropriate way. We ask, should anyone contact you regarding this matter that you refer them to the appropriate administration. The reason for our request is because you may elect to serve as the hearing officer. We're sorry legal council cannot be here tonight but they were already scheduled for another board meeting.

Mr. Heredia reminded Mr. Warren that he needed to state his name and address and present his comments. By law the Board members cannot discuss his allegations.

Mr. Michael Warren introduced himself to address the Board members, District Administration, parents, and students. "I am delighted to be here tonight and delighted to be a teacher for the district the last three years going into my fourth year teaching math. It has been a great experience. Presently I am on administrative leave and I just want to say that I should be in class teaching the students. I ask the Board do not accept any statement from any person until you investigate the charges." He continued by stating "My Conscience is clear and my hands are clean". Channel 11 has contacted me to make a live interview. Parents have called wondering why I'm not teaching. I'm going to do the interview and will be telling the truth. In closing when you hear the litigation

against me, I asked you to hear the real reason of the charges. I belong in the classroom with students. Thank you for your time".

Mrs. Dinora Conwell spoke on his behalf. She is a sixth grade science teacher at Somerton Middle School. She has been teaching with Mr. Warren, "I was transferred to sixth grade science without my request". She enjoys teaching. Mr. Warren is a respected fellow teacher who works extra hours, She has not seen anything wrong while working in the same building. She has not observed anything with her own eyes. She requested that the Board members if possible to go to Somerton Middle School and continue an extended investigation. She has seen things that were not right.

Dr. Reed submitted a written report on the 301 Plan . Mr. Heredia requested that the 301 Plan be a discussion item.

Mr. Heredia commented that the district needs to promote the tax credit deduction.
