2.c. Board Member Report

Information

Mr. Omer voiced his concern regarding over-the-counter (OTC) medications not being administered by school personnel because they are supposed to be provided by parents. He agreed that prescription meds should be provided by parents, but he feels that immediate attention may not be possible if families haven't provided their child's meds in advance.

Mrs. Bobbitt explained that compliance issues are being reviewed by staff and ASBA and will be presented to the Board at the October meeting.

Mrs. Liz Santos, District Health Coordinator, explained that Registered Nurses should work under the direction of a medical doctor. Currently, the District does not have a medical doctor willing to do this. Mrs. Santos feels that District health personnel are working under her license and does not want to jeopardize it with any unfortunate incidents.

Mr. Omer wants the children's health and well-being to be everyone's primary concern and doesn't want to worry about parents working an hour or more from the District having to provide their child with meds.

2.d. Overview on AIMS

Information

6:40 p.m. Mr. Sheppard presented the District's AIMS rankings and noted that all District schools did very well or higher than state level scores. Adequate Yearly Progress (AYP) is part of the federal government's No Child Left Behind educational act. It only looks at our AIMS scores and Reading and Math. It includes all students who are enrolled in the first ten days of school that are included within a subgroup of at least thirty students. Overall, our three elementary schools, did very well when compared to other county schools. Unfortunately, it took the state two years to distribute the correct 2000 test scores.

Category 2 begins at the first grade, these students are doing very well and EL strategies are being used effectively. Gender scores were not prepared for the Board's review because no trends were apparent.

Mr. Sheppard hopes to follow students that have been in the full-day kinder program until they leave eighth grade. The first group of full day District students are currently fifth graders. Mr. Sheppard explained that Dual Purpose Assessment (DAP) will show a clearer picture of where those students are. Across the state, fifth graders typically do better than eighth graders, our scores echoed this.

Mrs. Bobbitt explained that West Ed includes training that will address stimulation of children's higher level thinking skills. 7:08 p.m.

Mrs. Bobbitt explained that Ms. Fernández submitted the new teaching position for Desert Sonora and recommends Jeanne Magaña for the position. Mrs. Bobbitt said classroom size will be reduced by adding this position and instructional improvement funds are not used to fund the position.

Mr. Omer asked if the Motion would be for the position only or if it would include the recommended person. Mr. Heredia asked that funding decisions be made with care. Mrs. Bobbitt said the motion would be for the position and person being recommended. No further comments. Mr. Phillips entertained a Motion.

MOTION: Mr. Omer moved to approve the new Desert Sonora second grade teacher position and recommended Mrs. Magaña to fill the position. He agreed with Mr. Heredia and asked that caution be used when looking at funding. Mrs. Camacho thanked Ms. Fernández for her continued efforts to better her school. 4.4. Discussion and Possible Action on Procedures for Admission into La Esperanza (Accommodation School)

Mrs. Bobbitt explained that last year the District had five long-term suspension students. After the creation of La Esperanza Middle School, Mrs. Bobbitt has worked with Stella Watts, Cocopah Student Advocate, Mr. Bocio, La Esperanza Teacher, and parents for possible placement there. One student was placed, two are pending and the other two are attending another alternative school in Yuma.

Mrs. Bobbitt specifically asked that a Hearing Officer be used for long-term suspension cases, and as recommended by the Hearing Officer, Mrs. Bobbitt would be designated with the authority to immediately place students at La Esperanza, so as not to interrupt their education. The other option would be for the Board to make those decisions.

The Board agreed with Mrs. Bobbitt's recommendation because they don't want student(s)' education to be put on hold because they meet once a month. After the hearing is held, the Board will be given the opportunity to review and ratify a decision as they see fit. Parents are to be advised that they have the right to request an audience or hearing before the Board.

Mr. Phillips entertained a Motion to approve

4.5. Discussion on New School and Escalating Costs

Mr. Klein and Mrs. Bobbitt met with architects and construction representatives to discuss escalating costs that may delay new school construction. Four classrooms were eliminated to bring the cost down and they will be constructed in Phase II. The District is on the SFBs October Agenda. Mrs. Bobbitt has been in dialogue with Mr. Hogan and Spencer Smith to prepare.

When the new school is built, the full-day kinder classes from Tierra Del Sol and Desert Sonora will free up ten classrooms. Orange Grove will have their full-day kinder program for another year, until the second phase is completed.

Mr. Omer wondered what the SFB needed to understand the hardship they are putting on districts when allocating such limited funds. Mrs. Bobbitt said that the District is preparing a very strong argument to present at the SFB meeting in October and knows Mr. Hogan addressed this in his initial lawsuit. She added that throughout the state, when SFB meetings are held, they are held at districts where SFB money funded new buildings. After speaking to administrators of those districts, Mrs. Bobbitt understood that SFB did not primarily fund those buildings. There was no further discussion.

4.6. Discussion on Later Starting Date for the Beginning of School

Mrs. Bobbitt explained that additional information will be presented at the Study Session, but the District is examining cost-effectiveness for starting school in September. Utility costs were not available and an analysis of actual costs will be available at the Study Session. The Board asked for community input to see if this will make a difference for Migrant families.

4.2. A.R.S. §38-431.03 Executive Sessions

- Mr. Phillips Action
- **A.** Upon a public majority vote of the members constituting a quorum, a public body may hold an executive session but only for the following purposes:
 - 1. Discussion or consideration of employment, assignment, appointment, promotion, demotion, dismissal, salaries, disciplining or resignation of a public officer, appointee or employee of any public body, except that, with the exception of salary discussions, an officer, appointee or employee may demand that the discussion or consideration occur at a public meeting. The public body shall provide the officer, appointee or employee with written notice of the executive session as is appropriate but not less than twenty-four hours for the officer, appointee or employee to determine whether the discussion or consideration should occur at the public meeting.
 - 3. Discussion or consultation for legal advice with the attorney or attorneys of the public body.
 - **4.** Discussion or consultation with the attorneys of the public body in order to consider its position and instruct its attorneys regarding the public body's position regarding contracts that are the subject of negotiations, in pending or contemplated litigation or in settlement discussions conducted in order to avoid or resolve litigation.
