1. OPENING AND ANNOUNCEMENTS

Mrs. Kristina Ramirez spoke to the safety of District students who cross Main Street going to Somerton Middle School in the early morning. She asked the Board to research the possibility of having these students receive bus privileges even if they live beyond the mile radius as mandated by the state. She added that a lady was hit on Main Street and flown to Phoenix the night before the Board Meeting.

Since this is an Agenda Item, Mr. Heredia said the public can speak when it is called.

Mr. Heredia entertained a Motion to revise and/or approve Minutes as submitted and noted that the December 9 meeting had two Executive Sessions. The first addressed Student Discipline and the second Personnel matters. He recommended the Motion include both sessions for the December 9 meeting.

2. REPORTS

2.a. Superintendent's Report

Mrs. Bobbitt

Information

Mrs. Bobbitt congratulated Desert Sonora's Soaring Hawks Choir who received First Place at the County Competition earlier in the day.

Mrs. Bobbitt has been in discussion with administrators regarding public relations and future hiring of teaching staff. Recently, 34 schools in Detroit closed and District administrators will be attending a recruitment fair in Detroit, hoping to find staff for the upcoming year.

Yuma Education Foundation's Teacher of the Year Celebration Kick-Off was held recently and two Desert Sonora nominees attended, Jennifer Portz-Adair, their First Year Teacher, and Lupe Ullery for Special Education. Also in attendance were Mrs. Bobbitt, Ms. Fernandez, Ms. Merino, and Mr. Heredia attended.

Mrs. Bobbitt received an email update from ASA that explained a survey of 470 graduated teachers to see what attracted them to certain places of employment. 116 of those surveyed accepted offers in April. The District will try to get creative to entice people to our warm climate.

In anticipation of opening Valle Del Encanto Learning Center, Mrs. De La Fuente and Ms. Fernández began working with all kindergarten students at Desert Sonora on Wednesdays. Elective/Specials Teachers and librarians have been working with them. Desert Sonora is the only school that did not qualify for a Full-Day Kindergarten program, so this additional time will prepare children for next year. (Mrs. Camacho arrived at 5:25 p.m.)

Mr. Heredia asked about recruitment efforts and strategies appearing to be focused in the mid-west and feels it's important to hire local applicants, because they tend to stay longer. Mrs. Bobbitt explained that the District has been promoting paraprofessionals enrolling in programs like RISE or intern certification. Currently we have four such staff that soon will be receiving their degrees.

Mrs. Bobbitt mentioned that she has an opportunity for Aracely Rodriguez and her sister to attend a meeting with Senator Kennedy and key government education officials in Washington, D.C. as the District's guests. She will keep everyone posted.

2.b. Administrator's/Director's Report

Information

Mr. Heredia thanked Mr. Brick for the additional information he submitted regarding future staff needs. Mrs. Bobbitt mentioned that Ms. Witmer will have budget projections at the March Study Session. Mr. Heredia recommended 'pushing the envelope' within legal limits to budget for next year. Utilization of grants and other funding is an important piece to research.

Mr. Omer noted that full day kindergarten has made a difference in his daughter's case. He noted that his first two daughters attended regular half-day sessions and currently his five year old is reading entire books on her own, because she likes it. This is a feat that he attributes to the full day kindergarten. He congratulated Ms. Fernandez and Mrs. De La Fuente for thinking outside the box and preparing these students for their first grade year.

4.10. Discussion and Possible Action Regarding Transportation and Safety Issue for Students Residing South of Main Street

Mr. Klein noted that approximately 175 Middle School students live south of Main Street. Many of these students do not currently receive transportation. Three additional bus runs would be needed to improve the situation. Currently, the District does not have the vehicles nor the staff to do this.

The suggestion was made to research using a crossing attendant on Main Street. Mr. Phillips asked for dialogue with the City to see what alternatives they have or possibly additional police patrol, something do slow Main Street traffic. The Board agreed that children's safety is the priority.

A radius of one mile from schools is in question, this means that in some cases, homes could be outside the mile area. Mr. Klein will remeasure the area, but thought the area ended at the north side of Garvin Street.

The District recently issued SMS student ID for those eligible for transportation residing south of Main Street. It was noted that addresses may be incorrect allowing transportation for students outside the designated area, while others may live within the area and not receive transportation. Mr. Heredia mentioned that a light at Avenue F and Main Street may be installed. There was no action on this item.

4.11. Discussion and Possible Action of WACOG Head Start Use of District Facility

Mrs. Bobbitt recommended approval for WACOG Head Start to occupy the current preschool buildings located next to their current WACOG Carlisle Center.

A.R.S. §38-431.03 Executive Sessions

- A. Upon a public majority vote of the members constituting a quorum, a public body may hold an executive session but only for the following purposes:
 - 1. Discussion or consideration of employment, assignment, appointment, promotion, demotion, dismissal, salaries, disciplining or resignation of a public officer, appointee or employee of any public body, except that, with the exception of salary discussions, an officer, appointee or employee may demand that the discussion or consideration occur at a public meeting. The public body shall provide the officer, appointee or employee with written notice of the executive session as is appropriate but not less than twenty-four hours for the officer, appointee or employee to determine whether the discussion or consideration should occur at the public meeting.
 - 3. Discussion or consultation for legal advice with the attorney or attorneys of the public body.
 - 4. Discussion or consultation with the attorneys of the public body in order to consider its position and instruct its attorneys regarding the public body's position regarding contracts that are the subject of negotiations, in pending or contemplated litigation or in settlement discussions conducted in order to avoid or resolve litigation.

The Governing Board will enter in to Executive Session to consult with Somerton Elementary School District's attorney.
