Davis Pickering have begun the lighting project at Waterford Elementary. The light replacements are over 50% completed in the Elementary. The company has been working in the evenings so that there is no disruption to classes.

Graduation, as Mrs. Coleman mentioned, is in the early planning stages. The plan will include Kindergarten, 8th grade promotion and High School graduation. There will most likely be tickets for admission in order to control the attendance allowed.

Field trips will resume but with some restrictions. The restrictions include distance, who can attend and following the guidelines of the places visited. Teachers have been provided guidelines by Mr. Baldwin.

We have been working with the Port Authority and attorneys about the taxes at the Muskingum River plant purchased by the Port Authority. An agreement will be presented to the Board of Education in the near future with a possible 50% reduction in value for 4 years.
